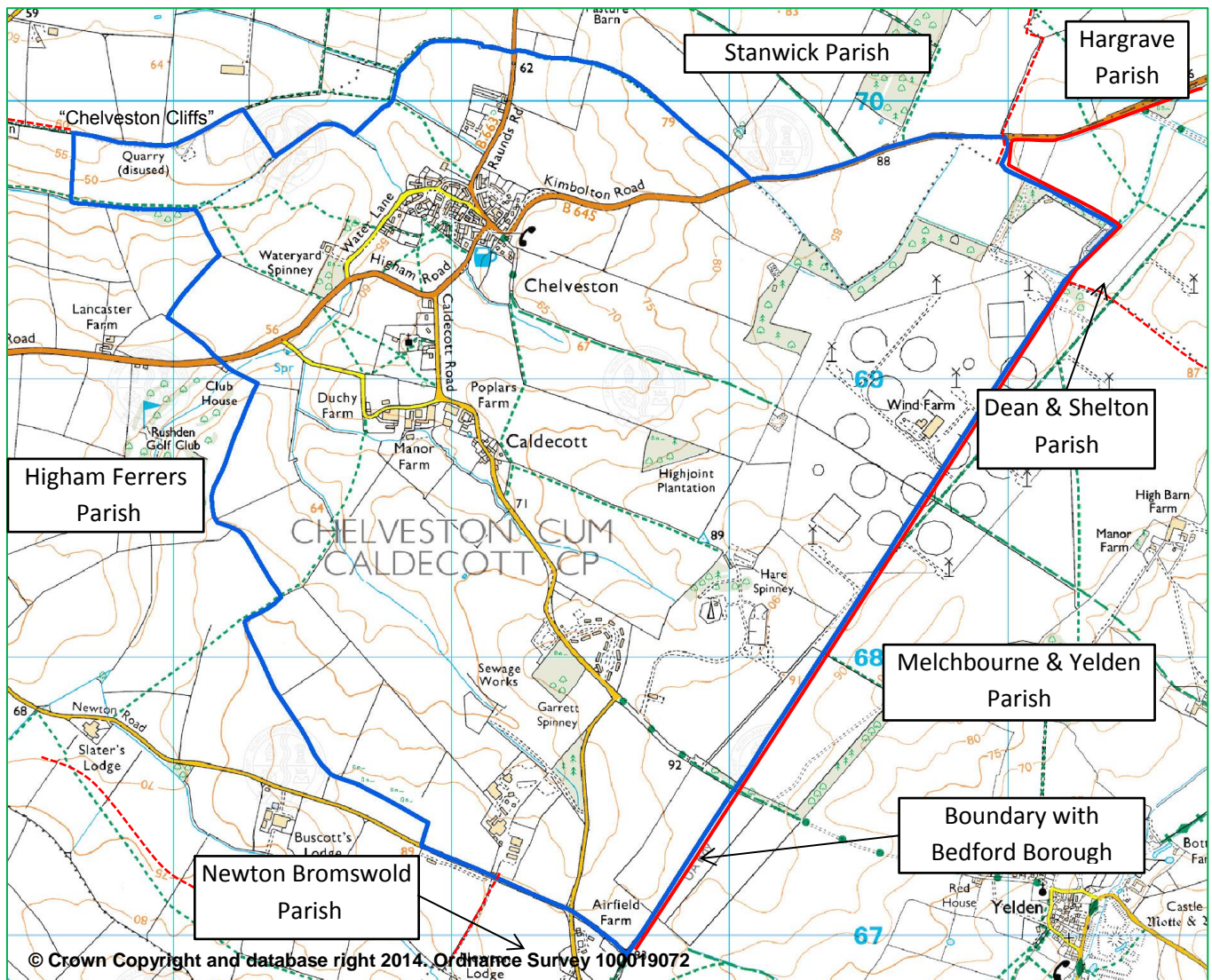

## SECTION 1: Pre-plan consultation with residents

This Consultation Statement has been prepared to fulfil the legal obligations of the **Neighbourhood Planning Regulations 2012. Section 15(2) of Part 5 of the Regulations** sets out what a Consultation Statement should contain:

- (a) contains details of the persons and bodies who were consulted about the proposed neighbourhood development plan;
- (b) explains how they were consulted;
- (c) summarises the main issues and concerns raised by the persons consulted;
- (d) describes how these issues and concerns have been considered and, where relevant, addressed in the proposed neighbourhood development plan.

At the Annual Parish Assembly in May 2012 (Ref [31](#)) residents agreed that the Parish should begin the preparation of a Neighbourhood Plan.

An exhibition entitled “**Chelveston-cum-Caldecott Past, Present, Future**” was then held in the Village Hall during December 2012. This showed residents how the Village had grown and developed since the 1800s, and asked them to consider how the Village should develop by 2035.

This exhibition was followed up by a detailed Village survey in January 2013. There was a **44%** response rate to this survey. In previous Village Appraisals (conducted in 1995, 2002, 2004 and 2010 – [Ref [9](#)]) a significant proportion of residents were strongly opposed to any further development in the Village. The 2013 survey showed a marked shift in opinion. Less than 17% of households now oppose all development. The majority of households indicated that they would support up to 20% growth over 20 years.

At the Annual Parish Assembly 2013 (Ref [32](#)) it was agreed to distribute the results of the survey to all households and to call for volunteers for join a Neighbourhood Plan Working Party.

## 1.2 Formulating the consultation process

In June 2013 the Working Party was set up, and one of their first jobs was to agree a **Statement of Community Involvement** and a **Community Engagement Strategy** [Refs [10](#), [11](#)].

The Working Party agreed that the whole process should be transparent and open. As far as was practical all meetings would be held in public. Residents and landowners would be invited to participate in a structured or unstructured way as appropriate to the meeting. From 1<sup>st</sup> July 2013, a cycle of monthly formal and informal (round table) meetings was organised. A register of attendees at each meeting was maintained and published after each meeting. The registers are shown in APPENDIX A. These public meetings continued until May 2014. At this point the Working Party began an 8-week drafting process to prepare the content of the plan. The Working Party then held numerous meetings in private to work through the many drafts.

Community engagement has been a key part of the project, and was heavily “front loaded” in order to generate the interest and momentum. The Working Party has issued newsletters to all households [Ref [21](#)] explaining the process and the progress made. These have been delivered on alternate months to the regular Parish Newsletter in which the Neighbourhood Plan was also featured. The aim of the Working Party was to ensure that all residents were aware of what was happening, and that they all had the opportunity to contribute and comment.

---

## 1.3 Determining the Neighbourhood Plan Area

In August 2013, the Working Party published their proposal for declaring a Neighbourhood Plan boundary [Ref [12](#)]. This was accepted by the Parish Council and submitted to East Northamptonshire Council on 2<sup>nd</sup> September 2013. It was then put through a formal 6-week consultation exercise by East Northamptonshire Council. No material comments were received during the formal consultation process. The Neighbourhood Plan Area Designation was approved on 12<sup>th</sup> February 2014.

On 15<sup>th</sup> October 2014, the **East Northamptonshire Council (Reorganisation of Community Governance) Order 2014** changed the boundaries of the Parish. On the 8<sup>th</sup> April 2015 East Northamptonshire Council approved the revised Neighbourhood Plan Area [Ref [57](#)].

---

## 1.4 Call for Aspirational Development Sites

In September 2013, a call for Aspirational Development Sites was sent to all land owners in the Parish [Ref [13](#)]. A general call was made to all residents through the Parish Newsletter in October 2013. 21 Aspirational Development Sites were submitted by the close of the call in November 2013. This consultation process is covered in Section 2.2.

---

## 1.5 Exhibition of Aspirational Development Sites

A 2-day exhibition of all the proposals was held during December 2013. The exhibition was prefaced by a series of historical maps showing how the Village had developed since the 19<sup>th</sup> century. Each phase of growth was shown, in order to demonstrate how the Village of today has evolved from two small



settlements. The Neighbourhood development process was also explained by means of posters (Ref [33](#)).

Members of the Working Party were on hand throughout the 2-day exhibition to explain the process.

Each page of the landowner submissions were displayed as A3 posters, together with satellite views and photographs to help orientate residents.

42% of all households in the Parish attended this exhibition and 61% of these provided detailed feedback (Ref [34](#)). A list of the attendees is available in APPENDIX A.

---

### 1.6 Landowner/Resident Consultation Meetings

Details of all proposals submitted were circulated to all households in the Parish (Ref [21c](#)). In January and February 2014 six consultation events were held [Ref [14](#)] to review each of the development sites in depth. Landowners presented their proposals and faced detailed questioning from residents. Residents also had the opportunity to submit questions and comments online. Over 200 questions and comments were received (see <http://ndp.chelveston.org.uk/view>). The consultation meetings were all well attended and **43%** of households participated in them. Attendees at these events are listed in APPENDIX A. Details of the consultation process at these meetings are provided in Section 2.3.

---

### 1.7 Residents' Poll on Aspirational Development Sites

In March 2014, a poll was conducted of all registered electors in the Parish. The poll was conducted under a strict protocol with the Clerk of the Parish Council as returning officer, [Ref [15](#)]. This poll focused on the revised propositions [Ref [16](#)] put forward by landowners following the consultation meetings.

Residents were asked to vote for the propositions that they supported (including reasons if possible), and to give their views on how the Village should develop over the next 20 years [Ref [17](#)].

**80%** of residents and **82%** of households participated in this poll. 3,484 individual comments were made during voting, allowing the Working Party to build up a very clear picture of what residents want to see. The criteria used to analyse the results were agreed and published [Ref [35](#)].

The propositions selected as preferred options were those that were able to command majority support of residents *if, and only if*, the propositions were modified to address the concerns of those residents giving only conditional support. Seven propositions secured majority support in this way and were incorporated into the Neighbourhood Plan.

## 1.8 Consultation with residents on the results of the poll

The results of the poll were presented at the Annual Parish Assembly in April 2014 [Refs [18](#), [19](#)] and a summary report was distributed to all households following this [Ref [20](#)]. The Annual Parish Assembly accepted the recommendations of the Working Party as to which propositions went forward as preferred options for development in the timescales specified.

## 1.9 Residents' consultation on the Draft Neighbourhood Plan

An informal consultation period of 6 weeks started on the 1<sup>st</sup> August 2014 for all land owners and residents.

As the complete draft plan (over 120 pages for all the documents) would have cost £2,500 to print a copy for each household, an alternative approach was taken.

1. All households and land owners were notified via a newsletter that the plan was available for review on the internet.
2. Loan copies of the full documentation were provided for a week for those households or land owners wishing to review a copy in detail.
3. A consultation evening was then held, during which plans were made available for study and presentations were made of the key features of the plan by the working party.

### 1.10 Comments from the informal consultation period

Two households commented on the plan. The Parish Council considered each of the comments in detail, publishing them in full, along with its response. [Ref. [48](#)].

---

### 1.11 Formal Regulation 14 Consultation

In January 2015 the Parish Council approved draft v2.0 of the plan to go to the formal "Regulation 14" consultation for all landowners, residents and statutory bodies. This process is covered in section 4.

---

### 1.12 Comments from the Formal Regulation 14 Consultation

A total of thirty three comments were received on the plan as follows:

- East Northampton Council (NDP-0238); 17 comments
- Statutory Bodies (NDP-0239); 11 comments
- Landowners (NDP-0239); 5 comments

The NDP Working Party considered these in detail, publishing them in full, along with its response.

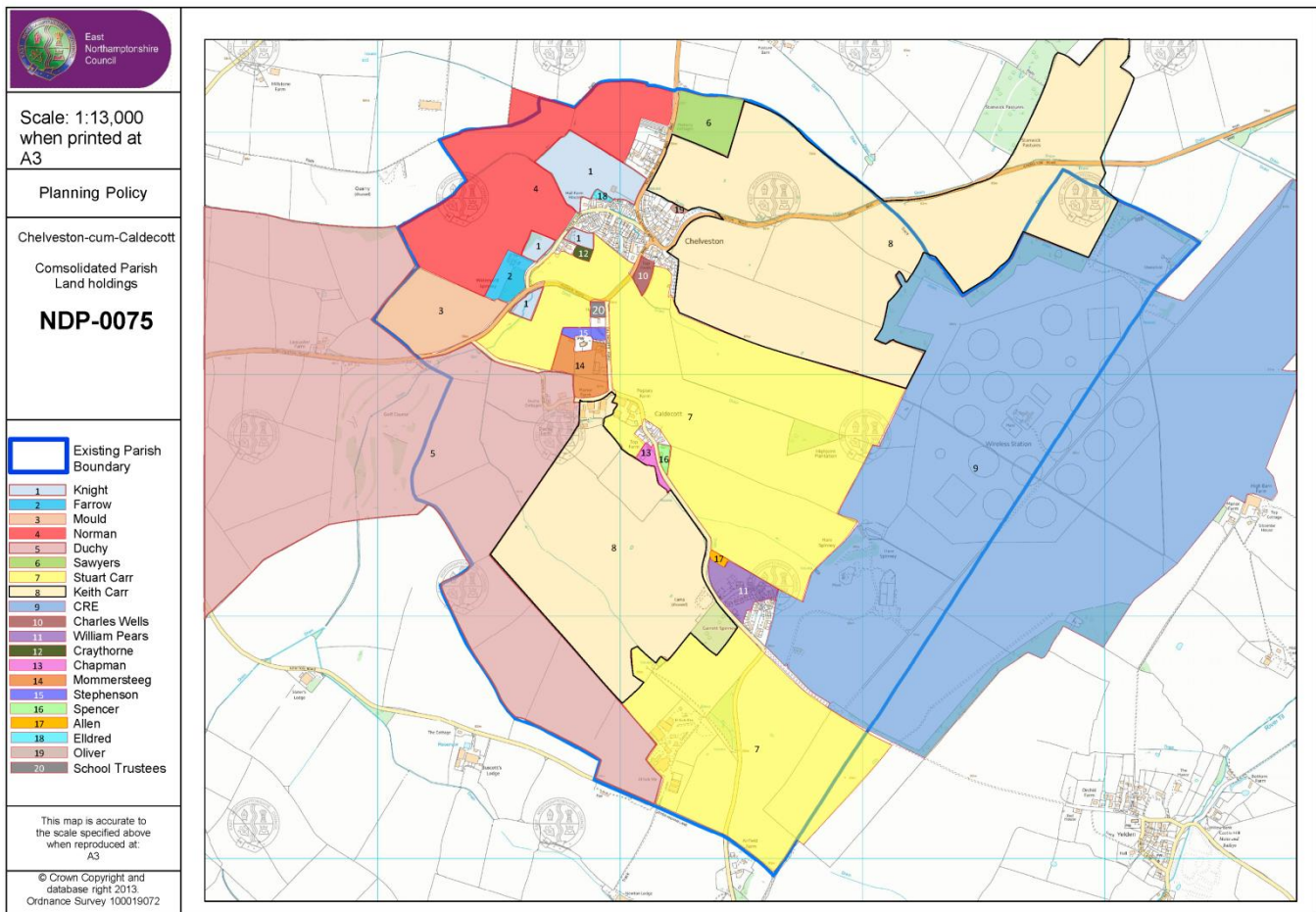
### 1.13 Formal Regulation 16 Consultation

In March 2016 the Parish Council approved draft v3.0 of the plan to go to East Northamptonshire Council for the formal "Regulation 16" consultation for all landowners, residents and statutory bodies [Ref [60](#)].

## SECTION 2: Landowner Consultation

### 2.1 Land holdings review

A comprehensive review of all landownership in the Parish was undertaken using local sources and the land registry. A map of all major land holdings was created and verified (Ref [29](#)). Some of the landowners reside outside the Parish, and a number of land holdings were found to be owned by corporate entities. All were successfully traced and invited to participate in the consultation. A list of the landowner consultees is provided in APPENDIX B. The land holdings at the time of consultation are shown below.



### 2.2 Call for Aspirational Development Sites

A personalised Call for Aspirational Sites (Ref [13](#)) was sent to all of the major land owners inviting them propose sites for development (housing or commercial).

A copy of the call was also delivered to all houses in the Village which had potential in-fill sites. A general call was issued to all other residents in the October 2013 Parish Newsletter.

Twenty five sites were proposed (Ref [30](#)), with some of these being alternative schemes. If all realised, these schemes would have resulted in the development of 145-192 new dwellings. This would have resulted in the Parish growing by 65-87%. This would significantly exceed the level of growth to be expected in a rural area by the North Northamptonshire Core Spatial Strategy (CSS). The CSS aims to

focus growth in the existing towns and in sustainable urban extensions. This level of growth also significantly exceeded the level that residents indicated they would accept in the January 2013 survey (Ref [9e](#)). Here residents indicated that 20% growth over 20 years would be broadly acceptable.

### 2.3 Landowner/Resident Consultation Meetings

Each of the consultation meetings were well publicised, first with a general newsletter (Ref [21c](#)), then e-mail reminders, and finally leaflet drops to each of the most affected properties before each meeting. The agendas were published on all Parish noticeboards and on the NDP website. An example is below:

In total 229 comments and questions were posted by residents and answered by the land owners. ## 2.4 Announcing the results of the poll to land owners

Prior to the Annual Parish Assembly, each landowner was issued with a detailed report which showed the votes cast in the poll for their proposition and any comments that were made. The full results were also published for analysis by the public [Refs [18](#)]. Landowners were given the opportunity to attend the public Working Party meeting where the results were discussed and approved [Ref [36](#)]. Questions were raised by some land owners regarding comments made in the poll by residents. They suggested that some of the comments were factually incorrect, indicating that some residents had not understood the propositions. The Working Party agreed that no weight would be given to factually incorrect comments in their analysis. However, the Working Party was also clear that such comments could not affect the results of the vote. It would not be possible or reasonable to discount a vote based upon whether a resident was considered to have understood a proposition.

### 2.5 Landowner consultation on the Draft Neighbourhood Plan (v1.0)

An informal consultation period of 6 weeks started on the 1<sup>st</sup> August 2014 for all land owners and residents.

As the complete draft plan (over 120 pages for all the documents) would have cost £2,500 to print a copy for each household, an alternative approach was taken.

1. All households and land owners were notified by newsletter that the plan was available for review on the internet.
2. Loan copies of the full documentation were provided for a week for those households or land owners wishing to review a copy in detail.
3. A consultation evening was then held during which plans were made available for study and presentations were made of the key features of the plan by the working party.

### 2.6 Comments from the informal consultation period on v1.0

Seven landowners provided detailed representations on Consultation v1.0. These representations were published in full, together with the Parish Council responses [Ref. [48](#)].

One landowner provided a follow up representation (with later revision) to the Parish Council responses [Ref. [49](#)].

All the representations made were taken into account in preparing the **Regulation 14** consultation version of the plan v2.0.

## SECTION 3: Screening Consultations

Using the East Northamptonshire Council toolkits the Chelveston-cum-Caldecott Neighbourhood Plan was put through the appropriate screenings for Strategic Environment Assessment [Ref. [54](#)] and the Habitat Regulations Assessment [Ref. [53](#)]. These screenings were sent out to statutory consultees on 19<sup>th</sup> November 2014. The following positive responses were received by the closing date of the consultation:

- Environment Agency [Ref. [55](#)]
- Natural England [Ref. [56](#)]

The NDP was also screened through the East Northamptonshire Council Equalities Impact Assessment [Ref. [50](#)]. No issues were apparent in this screening.

## SECTION 4: Regulation 14 consultation

It had been intended that the second version of the draft plan be issued for **Regulation 14** consultation in early November 2014. However, one of the landowners requested further time to prepare a further representation objecting to the Parish Council responses in Ref. [48](#). The Parish Council agreed to this extension, and a follow-up representation was received on 24<sup>th</sup> November 2014, with a further revision to this on 4<sup>th</sup> January 2014. [Ref [49](#)]

All of the representations received were taken into account before preparing the draft pre-submission plan (Consultation v2.0). This plan was approved by the Parish Council on 12<sup>th</sup> January 2015.

The **Regulation 14** consultation began on 26<sup>th</sup> January 2015 and ran for 6 weeks.
