Thank you for your offer to assist the Parish Council Working Party which will be preparing the Draft Neighbourhood Development Plan (NDP) in preparation for consultation with residents. We discussed your offer at the Parish Council meeting on Monday 10th June 2013 and concluded that your client's financial interest in the outcome of the plan constitutes a conflict of interest. We need to be able to convince the inspector and residents that the NDP has been developed in an unbiased way with a robust evidence trail.
